The Justice Project - progress report released

The Law Council's national review into the state of access to justice for people in Australia, who face significant economic and social disadvantage, has released a Progress Report in March.

Chaired by former High Court Chief Justice, the Hon. Robert French AC, the "Justice Project" conducted 133 consultations, including with government agencies, non-government organisations, advocacy and peak bodies, legal assistance services, court and tribunal personnel, sole practitioners, academics, subject matter experts and community elders.

The final report is expected later in 2018.

Legal Practice Management - new skills requirement in Victoria

To be granted a principal practising certificate that commences on or after 1 January 2019, lawyers who apply for a principal practising certificate will need to exhibit additional skills and expertise necessary to manage a law practice.

In order to satisfy this requirement of the Victorian Legal Services Board + Commissioner, a lawyer may complete a practice management course which has been assessed by the VLSB+C as meeting these guidelines.
